## **25 Arrested in Joint Operation “Summer Support”**

**[Atlantic County]** –On Thursday, July 23, 2015, the Atlantic County Sheriff’s Office completed a three day arrest sweep of individuals wanted for failure to make their court ordered child support payments and those wanted on criminal warrants issued by Superior Court Judges. Notable arrests, all out of Atlantic City, were: Eusebio Rosario, 55 and Willie Hardy, 57, arrested on criminal warrants issued for narcotics; Gregory L. Stamm, 52, arrested on two criminal warrants issued for aggravated assault, resisting arrest, as well as narcotics (photos attached).

Operation Summer Support was the Atlantic County component of the mandatory statewide child support initiative conducted July 21-23, 2015. During the three day sweep in Atlantic County, a combined 138 house checks were conducted by: Atlantic County Sheriff’s Office, Atlantic County Prosecutor’s Office, Atlantic City Task Force, Atlantic City Police Department, United State Marshal Service NY/NJ Regional Fugitive Task Force, FBI Innocence Lost Task Force. The Atlantic County Probation Child Support Enforcement Team also contributed to the operation.

“Law Enforcement working together in removing wanted people from our community streets contributes to a safer county and a better quality of life for all of our law abiding citizens”, stated Sheriff Frank X Balles.

In Atlantic County, ten people were arrested in total on Child Support Warrants and \$4,900.00 was collected from those arrested during the operation. Fifteen people wanted on Superior Court Criminal Warrants were also arrested in the sweep. A combined total of 13 warrants issued by the municipalities of Atlantic City, Egg Harbor Township, Hamilton Township, Brigantine, Middle Township, Ocean City, North Wildwood, and Wayne Township were cleared as a result of the 25 arrests made during the three day operation. An additional eight people originally targeted for this operation were arrested in the weeks prior to the actual three day sweep. Egg Harbor Township Police, Hamilton Township Police, Galloway Township Police and Atlantic City Police all contributed arrests of targeted individuals.

“It is necessary to work together with all Atlantic County based law enforcement agencies as a force multiplier to apprehend wanted criminals. In addition, we will continue our long standing partnership with all of the Sheriff’s Offices in New Jersey to routinely participate in statewide raids organized to arrest those people wanted by the Family Court for failure to pay their Court Ordered Child Support,” Balles said.

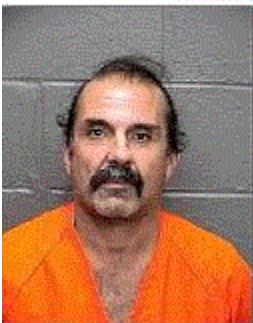
